NOTICE OF RACE

AMENDMENT #3

The original Notice of Race is changed as follows:

Section 1. Rules

Section 1.2 is changed as follows:

Section 1.2 There will be fifty (50) World Sailing points available for ILCA 7 Male and ILCA 6 Female and twenty-five (25) ILCA North American Grand Prix points available (in accordance with **Grand Prix Rules**) for all ILCA 7, ILCA 6 and ILCA 4 competitors participating in the regatta.

Section 4 Eligibility and Entry

Section 4.7 is changed as follows:

Section 4.7 The deadline for this registration for this regatta is midnight September 6th, 2023. Registrations will be accepted after midnight September 6, 2023 until midnight September 10th, 2023 with a \$40 USD late fee included.

Section 11. Scoring

Section 1.3 is changed to Section 11.3

Notice of Race AMENDMENT #2 is changed as follows:

Section 1. Rules

1.7 is changed to Section 1.6.

1.6 Masters Class (Rig swapping rule is turned off). Masters Class competitors must register, compete and be scored in either the ILCA 6 or ILCA 7 ACC Open class. Masters scores will be determined from the overall scores of the ILCA 6 and ILCA 7 ACC Open results.

Section 4 Eligibility and Entry

Section 4.10 Masters Class-is deleted

Section 7 Equipment Inspection

Section 7.2 is changed as follows:

Section 7.2 Masters Class only-The Organizing Authority will have available colored bands to place on the mast of Masters Class boats between the vang fitting and the gooseneck. The use of the color bands is optional. The bands will be distributed as described in **Section 7.2 on Amendment #2.**

Section 15. Prizes

Section 15. Prizes is changed as follows:

Master Class prizes will be awarded to the top three Masters finishers in both the (3) ILCA 7 and ILCA 6 classes along with the overall Masters winner as described in Sections 4.9 and Section 11.4 of Amendment #2.

It is the intention of the race committee to have ILCA 4, ILCA 6 and ILCA 7 race in the same course area with separate starts.

This amendment has been made to address issues related to the inclusion of the ACC Masters Championship Regatta and clarify the World Sailing and ILCA Grand Prix points available for this regatta.
